The Foundation and Club Sponsor hereinafter referred to as "the Parties";

Terms and Conditions

- Whereas The Foundation is a not for-profit institution incorporated in Spain, with NIF G85512424, and supervised by the Spanish Ministry of Culture, dedicated to the promotion and development of Georgia.
- Whereas The Foundation has created the Friends of Georgia Club to integrate all individuals that support the Foundation with donations (hereinafter referred to as "Club Members").
- Whereas The Club Sponsor, whose details are contained in Annex A, is a legally established service and/or product provider.
- Whereas The Club Sponsor has expressed its interest to offer Club Members a special treatment to reward them for the support they provide to the Foundation and its activities.

Now therefore the Parties hereby agree as follows:

1. The Foundation will include Club Sponsor's name, address, telephone number, discount/benefit, and restrictions in at least one of the Foundation's Web site and/or other collateral and promotional materials.
2. Club Sponsor agrees that at all times, during the Term of this Agreement, Club Sponsor will offer at least one (1) discount to Club Members presenting a valid Club Member Card. The discounts being initially offered are detailed in Annex A, and may be changed from time to time by the Club Sponsor, previously informing the Foundation of such change. Further, Club Sponsor agrees to educate all relevant employees on the Club Sponsor's participation in Friends of Georgia Club Program.
3. Club Sponsor agrees that the discount/benefit specified in this Agreement will be:
 - (i) The only ongoing offer Club Sponsor makes available to Friends of Georgia Club Members and;
 - (ii) The best offer (i.e. of highest value) made available to any Friends of Georgia Club Members during the Term of this Agreement.
4. Club Sponsor agrees that the Foundation may use Club Sponsor's name and logo to promote the Foundation and the Friends of Georgia Club.
5. Club Sponsor agrees to display a Friends of Georgia Club sticker and other collateral provided by the Foundation in its window, on its front door, or in another equally visible

location as to inform Friends of Georgia Club Members of Club Sponsor's participation in the Friends of Georgia Club Program.

6. Limitation of Liability: In no event will either party, its officers, directors, affiliates, employees, representatives, agents or shareholders be liable (either in contract, tort, warranty, or otherwise) to the other party or any of its officers, directors, affiliates, employees, representatives or shareholders, for any consequential, incidental or indirect damages, including costs, profits, cost savings or for any exemplary or punitive damages.

This Agreement is the entire Agreement between the parties. This Agreement does not constitute and shall not be constructed as constituting an agency, partnership or joint venture between The Foundation and Club Sponsor.

7. This Agreement begins on this date and shall continue thereafter until terminated. Either party may terminate this Agreement effective January 1st of the year in which such notice is delivered, provided that written notice shall be given on or before November 30th of the preceding year.
